Non-compliance with requirements under the Long-Term Care Homes Act, 2007 (LTCHA) was found. (A requirement under the LTCHA includes the requirements contained in the items listed in the definition of "requirement under this Act" in subsection 2(1) of the LTCHA.)

The following constitutes written notification of non-compliance under paragraph 1 of section 152 of the LTCHA.

WN #1: The Licensee has failed to comply with O.Reg 79/10, s. 221. Additional training — direct care staff

Specifically failed to comply with the following:

- s. 221. (1) For the purposes of paragraph 6 of subsection 76 (7) of the Act, the following are other areas in which training shall be provided to all staff who provide direct care to residents:
- 1. Falls prevention and management. O. Reg. 79/10, s. 221 (1).

1. The Licensee failed to ensure that direct care staff are provided training in falls prevention and management as evidenced by:

A review of the policy, Falls Prevention Program - # RCM 2.1 - Dated January 2012 - Revised June 20, 2013. under Staff Training and Education, indicates:

- 1. Falls prevention Program Policy will be reviewed with all new staff during orientation, including the importance of the program and the risk to residents' health due to falls.
- 2. Online Annual Training on Falls Prevention Program.

There is no documented evidence that direct care staff are provided annual training in falls prevention and management.

The Acting Director of Care confirmed there has been no formal falls prevention training provided to staff since April 2011. [s. 221. (1) 1.]

Additional Required Actions:

VPC - pursuant to the Long-Term Care Homes Act, 2007, S.O. 2007, c.8, s.152(2) the licensee is hereby requested to prepare a written plan of correction for achieving compliance to ensure that direct care staff are provided training in falls prevention and management, to be implemented voluntarily.
