- (a) each resident who is incontinent receives an assessment that includes identification of causal factors, patterns, type of incontinence and potential to restore function with specific interventions, and that where the condition or circumstances of the resident require, an assessment is conducted using a clinically appropriate assessment instrument that is specifically designed for assessment of incontinence;
- (b) each resident who is incontinent has an individualized plan, as part of his or her plan of care, to promote and manage bowel and bladder continence based on the assessment and that the plan is implemented;
- (c) each resident who is unable to toilet independently some or all of the time receives assistance from staff to manage and maintain continence;
- (d) each resident who is incontinent and has been assessed as being potentially continent or continent some of the time receives the assistance and support from staff to become continent or continent some of the time;
- (e) continence care products are not used as an alternative to providing assistance to a person to toilet;
- (f) there are a range of continence care products available and accessible to residents and staff at all times, and in sufficient quantities for all required changes;
- (g) residents who require continence care products have sufficient changes to remain clean, dry and comfortable; and
- (h) residents are provided with a range of continence care products that,
- (i) are based on their individual assessed needs,
- (ii) properly fit the residents,
- (iii) promote resident comfort, ease of use, dignity and good skin integrity,
- (iv) promote continued independence wherever possible, and
- (v) are appropriate for the time of day, and for the individual resident's type of incontinence. O. Reg. 79/10, s. 51 (2).

- 1. The licensee has not ensured that the resident who is incontinent receives an assessment that: Includes identification of causal factors, patterns, type of incontinence and the potential to restore function with specific interventions. [O.Reg 79/10 s.51(2)a]
- a) An identified resident has not received an assessment related to continence that includes the above requirements under section 51(2)a of the regulation. The assessment did not include identification of causal factors, patterns, type of incontinence and the potential to restore function with specific interventions.
- 2. The licensee has not ensured that: Each resident who is unable to toilet independently some or all of the time receives assistance from staff to manage and maintain continence. [O.Reg 79/10 s.51(2)c]
- a) An identified resident who is unable to toilet independently some or all of the time, did not receive assistance from staff to manage and maintain continence. The resident was found on several occasions with clothing, bedding and wheelchair soaked with urine indicating that assistance had not been provided as outlined in the plan of care.

CO # - 001 will be served on the licensee. Refer to the "Order(s) of the Inspector".

WN #2: The Licensee has failed to comply with LTCHA, 2007 S.O. 2007, c.8, s. 6. Plan of care Specifically failed to comply with the following subsections:

- s. 6. (1) Every licensee of a long-term care home shall ensure that there is a written plan of care for each resident that sets out.
- (a) the planned care for the resident;
- (b) the goals the care is intended to achieve; and
- (c) clear directions to staff and others who provide direct care to the resident. 2007, c. 8, s. 6 (1).
- s. 6. (7) The licensee shall ensure that the care set out in the plan of care is provided to the resident as specified in the plan. 2007, c. 8, s. 6 (7).

Findings/Faits saillants:

- 1. The licensee has not ensured that there is a written plan of care for each resident that sets out: Clear direction to staff and others who provide direct care to the resident. [LTCHA 2007, S.O.2007 c.8, s6(1)c]
- a) An identified resident did not have a plan of care that provided clear directions to staff and others who provide direct care to the resident in relation to responsive behaviours and PASD (Personal Assistive Service Device) care.
- 2. The licensee has not ensured that the care set out in the plan of care is provided to the resident as specified in the plan. [LTCHA 2007, S.O.2007, c.8, s6(7)]
- a) An identified resident did not receive care as set out in the plan of care in relation to repositioning and skin care, continence care, and care required with a PASD.

Additional Required Actions:

VPC - pursuant to the Long-Term Care Homes Act, 2007, S.O. 2007, c.8, s.152(2) the licensee is hereby requested to prepare a written plan of correction for achieving compliance related to ensuring that care set out in the plan of care is provided to the resident as specified in the plan, to be implemented voluntarily.

WN #3: The Licensee has failed to comply with O.Reg 79/10, s. 26. Plan of care Specifically failed to comply with the following subsections:

- s. 26. (3) A plan of care must be based on, at a minimum, interdisciplinary assessment of the following with respect to the resident:
- 1. Customary routines.
- 2. Cognition ability.
- 3. Communication abilities, including hearing and language.
- 4. Vision.
- 5. Mood and behaviour patterns, including wandering, any identified responsive behaviours, any potential behavioural triggers and variations in resident functioning at different times of the day.
- 6. Psychological well-being.
- 7. Physical functioning, and the type and level of assistance that is required relating to activities of daily living, including hygiene and grooming.
- 8. Continence, including bladder and bowel elimination.
- 9. Disease diagnosis.
- 10. Health conditions, including allergies, pain, risk of falls and other special needs.
- 11. Seasonal risk relating to hot weather.
- 12. Dental and oral status, including oral hygiene.
- 13. Nutritional status, including height, weight and any risks relating to nutrition care.
- 14. Hydration status and any risks relating to hydration.
- 15. Skin condition, including altered skin integrity and foot conditions.
- 16. Activity patterns and pursuits.
- 17. Drugs and treatments.
- 18. Special treatments and interventions.
- 19. Safety risks.
- 20. Nausea and vomiting.
- 21. Sleep patterns and preferences.
- 22. Cultural, spiritual and religious preferences and age-related needs and preferences.
- 23. Potential for discharge. O. Reg. 79/10, s. 26 (3).

Findings/Faits saillants:

- 1. The licensee has not ensured that the residents plan of care is based on an interdisciplinary assessment of the residents continence, including bladder and bowel elimination. [O.Reg 79/10 s 26(3)8]
- a) The plan of care for an identified resident was not based on an interdisciplinary assessment of the resident related to continence and bowel management. The assessment completed for continence was signed as completed by nursing only without any evidence that any other discipline was involved in determining the physical abilities, restorative potential of the resident or care needs required by the resident in relation to continence.

Additional Required Actions:

VPC - pursuant to the Long-Term Care Homes Act, 2007, S.O. 2007, c.8, s.152(2) the licensee is hereby requested to prepare a written plan of correction for achieving compliance related to ensuring that the residents plan of care is based on an interdisciplinary assessment of the resident's continence, to be implemented voluntarily.

WN #4: The Licensee has failed to comply with O.Reg 79/10, s. 30. General requirements

- 1. The licensee has not ensured that any actions taken with respect to a resident under a program, including assessments, reassessments, interventions and the residents response to interventions, are documented. [LTCHA 2007, S.O.2007 c.8, s.30(2)]
- a) During the quarterly reviews completed using RAI MDS (Resident Assessment Instrument Minimum Data Set) for an identified resident, there have been no recorded resident responses to the interventions outlined in the plan of care for continence, falls, PASD (Personal Assistive Service Device), and responsive behaviours.

Additional Required Actions:

VPC - pursuant to the Long-Term Care Homes Act, 2007, S.O. 2007, c.8, s.152(2) the licensee is hereby requested to prepare a written plan of correction for achieving compliance related to ensuring that resident's response to interventions in the plan of care is documented, to be implemented voluntarily.

WN #5: The Licensee has failed to comply with O.Reg 79/10, s. 131. Administration of drugs Specifically failed to comply with the following subsections:

s. 131. (2) The licensee shall ensure that drugs are administered to residents in accordance with the directions for use specified by the prescriber. O. Reg. 79/10, s. 131 (2).

Findings/Faits saillants:

- 1. The Licensee has not ensured that drugs are administered to residents in accordance with the directions for use specified by the prescriber. [O.Reg 79/10 s.131(2)]
- a) Registered staff of the home did not review the dosage of a medication to ensure the correct amount was administered to an identified resident. The resident continued to receive the incorrect dose of medication for approximately 5 months.

If the Licensee is not served with written notice of the Director's decision within 28 days of receipt of the Licensee's request for review, this(these) Order(s) is(are) deemed to be confirmed by the Director and the Licensee is deemed to have been served with a copy of that decision on the expiry of the 28 day period.

The Licensee has the right to appeal the Director's decision on a request for review of an Inspector's Order(s) to the Health Services Appeal and Review Board (HSARB) in accordance with section 164 of the Long-Term Care Homes Act, 2007.
