- 2. Abuse of a resident by anyone or neglect of a resident by the licensee or staff that resulted in harm or a risk of harm to the resident. 2007, c. 8, s. 24 (1), 195 (2).
- 3. Unlawful conduct that resulted in harm or a risk of harm to a resident. 2007, c. 8, s. 24 (1), 195 (2).
- 4. Misuse or misappropriation of a resident's money. 2007, c. 8, s. 24 (1), 195 (2).
- 5. Misuse or misappropriation of funding provided to a licensee under this Act or the Local Health System Integration Act, 2006. 2007, c. 8, s. 24 (1), 195 (2).

- 1. The licensee failed to ensure that any person who had reasonable grounds to suspect that any of the following had occurred immediately report the suspicion and the information upon which it was based to the Director.
- 2. Abuse of a resident by anyone or neglect of a resident by the licensee or staff that resulted in harm or risk of harm.

Previously issued as a Written Notification (WN) March 23, 2011.

In August 2013 resident #001 reported to a Personal Support Worker responsible for their care that sexual touching had occurred during the night. The resident indicated at the time of reporting that they were in pain.

Management of the home were notified at the time of the incident, of the allegation of abuse.

The allegation of abuse was not reported to the Director until thirty-two hours after the incident when a Critical Incident Report was submitted.

Interview with the Director of Care confirmed that the after hours number was not called at the time that the home became aware of the allegation of abuse. [s. 24. (1)]

Additional Required Actions:

VPC - pursuant to the Long-Term Care Homes Act, 2007, S.O. 2007, c.8, s.152(2) the licensee is hereby requested to prepare a written plan of correction for achieving compliance ensuring that any person who has reasonable grounds to suspect that, abuse of a resident by anyone or neglect of a resident by the licensee or staff that resulted in harm or risk of harm, immediately report the suspicion and the information upon which it is based to the Director, to be implemented voluntarily.
