The purpose of this inspection was to conduct a Resident Quality Inspection inspection.

This inspection was conducted on the following date(s): August 9-12, 2016

Two Critical Incidents were inspected concurrently with this RQI, an unexpected death and an injury to a resident for which the resident is taken to hospital and which results in a significant change in the resident's health status.

During the course of the inspection, the inspector(s) spoke with the Administrator, the Director of Care, an Assistant Director of Care, the Food Service Manager, the Environmental Manager, the Food Service Supervisor, the RAI coordinator, Registered Nurses, Registered Practical Nurses, Personal Support Workers, the president of the Resident Council, a Family Council Representative and Residents.

WN #1: The Licensee has failed to comply with O.Reg 79/10, s. 68. Nutrition care and hydration programs

Specifically failed to comply with the following:

s. 68. (2) Every licensee of a long-term care home shall ensure that the programs include,

(a) the development and implementation, in consultation with a registered dietitian who is a member of the staff of the home, of policies and procedures relating to nutrition care and dietary services and hydration; O. Reg. 79/10, s. 68 (2).

(b) the identification of any risks related to nutrition care and dietary services and hydration; O. Reg. 79/10, s. 68 (2).

(c) the implementation of interventions to mitigate and manage those risks; O. Reg. 79/10, s. 68 (2).

(d) a system to monitor and evaluate the food and fluid intake of residents with identified risks related to nutrition and hydration; and O. Reg. 79/10, s. 68 (2).

(e) a weight monitoring system to measure and record with respect to each resident,

(i) weight on admission and monthly thereafter, and

(ii) body mass index and height upon admission and annually thereafter. O. Reg. 79/10, s. 68 (2).

Findings/Faits saillants :

1. Inspectors conducted a review of resident records as part of the Resident Quality Inspection (RQI). The most recent height entered for all residents was completed in 2012.

Inspector #541 interviewed the Director of Care (DOC) who indicated her expectation is that heights are completed annually and entered into the electronic record system, PointCick Care. When informed the heights have not been completed since 2012, the DOC informed inspector #541 that the person responsible for completing annual heights was off on a long-term leave and the responsibility had not been passed onto another person. As per the DOC, the home has now developed a process to have all annual heights completed by the end of the next quarter. [s. 68. (2) (e) (ii)]
