The purpose of this inspection was to conduct a Complaint inspection.

This inspection was conducted on the following date(s): March 02, 05, 07, 08 and 12, 2018

One complaint was inspected regarding the reporting of alleged physical abuse from a resident to co-residents (Log # 004559-18).

One Critical Incident was also inspected, Log # 029480-17 regarding the reporting of alleged physical abuse.

During the course of the inspection, the inspector(s) spoke with the home's President and Chief Executive Officer, the Vice President of Nursing (VPN), the Assistant Vice President of Nursing (AVPC), the Administrative Coordinator, Registered Nurses (R.N.), Registered Practical Nurses (R.P.N.), Personal Support Workers (PSW), Sitters and several Residents.

During the course of the inspection, the inspector conducted a tour of the resident care areas, reviewed residents' health care records, staff work routines, observed resident rooms, resident common areas, the delivery of resident care and services and staff to resident and resident to resident interactions.
