The purpose of this inspection was to conduct a Follow up inspection.

This inspection was conducted on the following date(s): March 17-19, 2021.

The following intake was completed during this follow up inspection:

Log #024200-20, follow up to compliance order (CO) #001 from inspection #2020_800532_0025, related to plan of care and falls prevention and management.

During the course of the inspection, the inspector(s) spoke with the Administrator, Assistant Director of Care (ADOC), Infection Prevention and Control (IPAC) Lead, Revera IPAC specialist, Public Health representative, Falls Lead, Registered Nurses (RN), Personal Support Workers (PSW), housekeeping staff, and residents.

The inspector(s) toured the home and observed staff to resident interactions, infection prevention and control practices and safety conditions of the home. They also reviewed clinical records, the home's policies and procedures, and documents pertinent to the inspection.

Specifically failed to comply with the following:

s. 229. (4) The licensee shall ensure that all staff participate in the implementation of the program. O. Reg. 79/10, s. 229 (4).

Findings/Faits saillants :

1. The licensee has failed to ensure that staff participated in the implementation of the home's IPAC program in relation to disinfecting eye protection when required.

On March 17, 2020, the Premier of Ontario and Cabinet issued a COVID-19 emergency in the Province of Ontario under the Emergency Management and Civil Protection Act.

On March 22 and 30, 2020, Directive #3 was issued and revised on December 7, 2020, to all Long-Term Care Homes (LTC Homes) under the Long-Term Care Homes Act (LTCHA), 2007, under section 77.7 of the Health Protection and Promotion Act (HPPA) R.S.O. 1990, c H.7. by the Chief Medical Officer of Health (CMOH) of Ontario. The CMOH advised that residents of LTC Homes were at immediate and increased risk of COVID-19 and an urgent requirement was made for all LTC Homes to implement measures to protect all residents and staff.

At the time of this inspection, there were multiple residents on contact and droplet precautions in relation to symptoms compatible with COVID-19 or sharing a room with someone who was symptomatic. Staff were to wear eye protection when they were within two meters of these residents.

Public Health Ontario (PHO) signage was posted on the door of these residents' rooms. The signage indicated eye protection was considered contaminated when staff entered a room of a resident on routine or additional precautions. According to Public Health, staff should disinfect their eye protection if they could not maintain two meters from a resident on these precautions.

On two occasions, two staff members were observed to be in contact and within two meters of three residents who were on droplet-contact precautions when administering medications in their rooms. The staff did not disinfect their face shield before exiting the residents' rooms.

Staff failing to disinfect their eye protection when required increased the risk of exposure

and transmission of viruses and bacteria to residents and staff throughout the home.

Additional Required Actions:

VPC - pursuant to the Long-Term Care Homes Act, 2007, S.O. 2007, c.8, s.152(2) the licensee is hereby requested to prepare a written plan of correction for achieving compliance to ensure that staff participate in the implementation of the home's Infection Prevention and Control (IPAC) program, to be implemented voluntarily.
