The purpose of this inspection was to conduct a Proactive Compliance Inspection.

This inspection was conducted on the following date(s): February 24, 25, 28, March 1, 2, 3, 4, 5 and 7, 2022.

Environmental Inspector Iqbal Kalsi participated in this inspection as an observer.

During the course of the inspection, the inspector(s) spoke with the Executive Director, the Director of Care - Pain Lead, the Recreation Program Manager, the Food Service Manager, the Registered Nurse (RN) - Infection Prevention and Control Lead, three RNs, the Registered Practical Nurse (RPN) - Falls Lead, the RPN - Skin and Wound Lead, a student RN, a Dietary Aide, two Personal Support Workers, two Housekeepers, the Residents' Council President, the Family Council President and residents.

The inspectors also completed a tour of the home, observed resident rooms and common areas, observed Infection Prevention and Control practices within the home, observed residents and the care provided to them, medication administration, medication storage areas, meal and snack service, reviewed clinical records for identified residents, medication incident reports, reviewed the home's Fall Prevention program, the Skin and Wound program and the Pain Program and other relevant policies and procedures.
