**WN #1: The Licensee has failed to comply with O.Reg 79/10, s. 8. Policies, etc., to be followed, and records Specifically failed to comply with the following subsections:**

**s. 8. (1) Where the Act or this Regulation requires the licensee of a long-term care home to have, institute or otherwise put in place any plan, policy, protocol, procedure, strategy or system, the licensee is required to ensure that the plan, policy, protocol, procedure, strategy or system,**  
**(a) is in compliance with and is implemented in accordance with applicable requirements under the Act; and**  
**(b) is complied with. O. Reg. 79/10, s. 8 (1).**

**Findings/Faits saillants :**

1. The policy for the home's Wound and Skin Care Program states that an interdisciplinary wound care team with membership from all disciplines will meet quarterly and discuss the wound care status and plan of treatment for residents with wounds.  
 Minutes were produced for one meeting which was held recently with attendance of only two nursing staff. There was no discussion recorded in the minutes about wound care status and plan of treatment for specific residents. The Director of Care confirmed that the committee has only held one meeting this year and is in the process of becoming re-established.

**Additional Required Actions:**

**VPC - pursuant to the Long-Term Care Homes Act, 2007, S.O. 2007, c.8, s.152(2) the licensee is hereby requested to prepare a written plan of correction for achieving compliance with ensuring that a policy for the Wound and Skin care program is implemented in accordance with applicable requirements under the Act, to be implemented voluntarily.**
