The follow-up inspections were related to residents plans of care and assessment of residents bed systems which were issued with the February 2, 2015 Resident Quality Inspection

During the course of the inspection, the inspector(s) spoke with the Administrator, Acting Director of Nursing and Personal Care, the Resident Admission Clinical and Practice Nurse, the Manager of Building Services, one Registered Nurse, one Registered Practical Nurse and two Personal Service Workers.

Seven resident clinical records and the home's Bed System and Entrapment Prevention Program and Policy were reviewed as well as the home's record for completion of resident bed system assessments.
