The purpose of this inspection was to conduct a Follow up inspection.

During the course of the inspection, the inspector(s) spoke with the Administrator, Manager of Resident Care, Resident Care Coordinators, Minimum Data Set - Resident Assessment Instrument (MDS-RAI) Coordinator, Registered Nurses, Registered Practical Nurses, Personal Support Workers and a Senior Maintenance Technician.

The inspector also toured the home, including Spa rooms to ensure shower chairs were in good repair, observed care provision and staff to resident interactions, reviewed risk management reports, maintenance request log book and completed work orders, residents' clinical records, meeting minutes and relevant policies and procedures.
