Inspection Summary/Résumé de l'inspection

The purpose of this inspection was to conduct an Other inspection.

This inspection was conducted on the following date(s): July 2, 3, 4, 2019

The following intake was completed in the Other inspection: Log #007645-19, which was related to bed rail use.

A compliance order (CO) was served on November 2, 2018 as a result of Critical Incident (CI) inspection #2018_625133_0022, in relation to bed rail use. The due date for the CO was April 5, 2019. A change of licensee occurred on April 1, 2019. The new licensee has a condition on the transfer of the licence that the new licensee complies with all outstanding orders made against the previous licensee. As a result of this inspection, it has been determined that the new licensee has complied with the outstanding order issued as a result of the CI inspection (#2018_625133_0022), related to bed rail use.

During the course of the inspection, the inspector(s) spoke with the Manager of CQI and Risk, the Director of Resident Care, the Maintenance Coordinators, the Assistant Environmental Coordinator, registered and non-registered nursing staff, and residents.

During the course of the inspection, the Inspector reviewed health care records and documentation related to bed system evaluation, the Inspector observed residents' bed systems and identified residents in bed with bed rails in use.
