WN #1: The Licensee has failed to comply with O.Reg 79/10, s. 131. Administration of drugs

Specifically failed to comply with the following subsections:

**s. 131. (3) Subject to subsections (4) and (5), the licensee shall ensure that no person administers a drug to a resident in the home unless that person is a physician, dentist, registered nurse or a registered practical nurse.
O. Reg. 79/10, s. 131 (3).**

Findings/Faits saillants :

1. The following finding indicates that the licensee failed to comply with O.Reg. 79/10 s. 131(3) in that they did not ensure that no person administers a drug to a resident in the home unless that person is a physician, dentist, registered nurse or a registered practical nurse (RPN).
2. On November 15, 2011 inspector #197 interviewed the Administrator, who stated she had witnessed a RPN give a family member medication to administer to an identified resident and the RPN did not stay to ensure that the medication was administered. An interview conducted by inspector #166 with the Administrator and Director of Care on November 16, 2011 re-confirmed this information.
