**Non-compliance with: O. Reg. 246/22, s. 270 (3)**

s. 270 (3) The licensee shall ensure that the attestation is submitted annually to the Director.

The licensee has failed to ensure that the emergency planning attestation was submitted annually to the Director.

**Rationale and Summary:**

The Ministry of Long-Term Care (MLTC) did not receive the homes Emergency Planning Attestation form by the due date of December 31, 2023.

The Administrator stated that they did not recall submitting the attestation.

The homes failure to submit the attestation posed a risk that the home did not have or was not reviewing and revising emergency plans.
