The purpose of this inspection was to conduct a Critical Incident System inspection.

This inspection was conducted on the following date(s): November 19 - 21, 2018

The inspection included:

Log #024270-18 (CIS #2747-000006-18) - regarding resident to resident abuse.

Log #029091-18 (CIS #2747-000008-18) - regarding fall with injury and transfer to hospital.

During the course of the inspection, the inspector(s) spoke with residents, Personal Support Workers (PSW), Registered Practical Nurses (RPN), Registered Nurses (RN), the acting Director of Care (DOC) and the Administrator.

In addition, observations of resident care and service delivery on multiple units were completed. A review of electronic records, investigation documentation and relevant Long-Term Care home policies including Falls Prevention and Management Program and Abuse & Neglect of a Resident - Actual or Suspected was also conducted.
