**The purpose of this inspection was to conduct a Critical Incident System inspection.**

**This inspection was conducted on the following date(s): April 15 - 18, 23 - 24, 2019.**

**Critical Incident (CIS) log #007607-19 (2747-000003-19) was inspected, related to allegations of staff to resident physical abuse. A complaint log #007531-19 related to the same incident, was also completed during this CIS inspection. Non-compliance was identified as a result of this CIS and is captured in the complaint report (2019\_730593\_0011).**

**During the course of the inspection, the inspector(s) spoke with the Administrator, Director of Care (DOC), the Physiotherapist (PT), Registered Nursing staff, Personal Support Workers (PSW), residents and family members.**
