Inspection Summary/Résumé de l'inspection

The purpose of this inspection was to conduct a Critical Incident System inspection.

This inspection was conducted on the following date(s): October 21 and 22, 2020.

Log #006382-20, a critical incident (CI #2747-000008-20) related to an allegation of resident abuse

During the course of the inspection, the inspector(s) spoke with the Administrator, the Acting Director of Care, a Registered Nurse, a Registered Practical Nurse, several Personal Support Workers, and a resident.

In addition, observations were conducted of the resident home area and a review of relevant records was completed including several resident healthcare records, employee training records for lifts and transfers, a written statement which detailed video footage, and several policies including policy #VII-L-40.40 'Lift Procedures' revised January 2016, policy #VII-L-40.40(f) 'Care and Use of Mechanical Lift Slings Protocol' revised January 2016, policy #VI-L-40.50 'Mechanical Lift and Sling Protocol' revised January 2016, and policy #VI-L-40.00 'Zero Lift Policy' revised April 2019.
