**The purpose of this inspection was to conduct a Follow up inspection.**

**This inspection was conducted on the following date(s): March 21-25 and March 28-31, 2022.**

- One log related to Compliance Order (CO) #001 from inspection report #2021\_745690\_0023 under r. 33. (1) of Ontario Regulation (O. Reg.) 79/10, related to the required minimum of twice a week bathing not being provided, and,
- One log related to CO #001 from inspection report #2021\_745690\_0024 under r. 8. (1) (b) of O. Reg. 79/10, related to the home's falls prevention management and procedures not being complied with.

**A Critical Incident System (CIS) Inspection #2022\_906687\_0003 was conducted concurrently with this inspection.**

**During the course of the inspection, the inspector(s) spoke with the Administrator, Director of Care (DOC), Infection Prevention and Control (IPAC) Lead, Maintenance Manager, Environmental Support Services Manager, Registered Nurses (RNs), Registered Practical Nurses (RPNs), Social Worker, Maintenance Coordinator, Administrative Assistants, Personal Support Workers (PSWs), Housekeepers, Recreation Aide, COVID-19 Screener, family members and residents.**

**The Inspectors conducted daily observations of the provision of care to the residents, staff to resident interactions, Infection Prevention and Control (IPAC) practices, and reviewed health care records, as well as relevant policies and procedures.**
