**WN #1: The Licensee has failed to comply with LTCHA, 2007 S.O. 2007, c.8, s. 6.
Plan of care**

Specifically failed to comply with the following:

s. 6. (7) The licensee shall ensure that the care set out in the plan of care is provided to the resident as specified in the plan. 2007, c. 8, s. 6 (7).

Findings/Faits saillants :

1. The licensee has failed to ensure that the care set out in the plan of care is provided to the resident as specified in the plan.

The MOHLTC received a Critical Incident (CI) report related to an incident that involved an identified resident. Record review of the CI revealed that on a specified date in October 2015, the identified resident was found on the floor; the resident was in bed prior to the fall. The identified resident was assessed by registered staff, then transferred to hospital due to experiencing pain.

Record review of the identified resident's care plan and kardex indicated that the resident was on a restorative toileting program, with toileting at five specified times throughout the day and evening shifts.

Interview conducted with an identified personal support worker revealed that on the above mentioned specified date in October 2015, he/she assisted the identified resident with toileting only once during the evening shift, and couldn't remember what the resident's plan of care indicated regarding his/her toileting needs. Additional Required Actions:

***VPC - pursuant to the Long-Term Care Homes Act, 2007, S.O. 2007, c.8, s.152(2)
the licensee is hereby requested to prepare a written plan of correction for
achieving compliance to ensure that the care set out in the plan of care is provided
to the resident as specified in the plan, to be implemented voluntarily.***
