Inspection Summary/Résumé de l'inspection

The purpose of this inspection was to conduct a Critical Incident System inspection.

This inspection was conducted on the following date(s): June 30, July 2, 5, 6, 7, 2021.

The following intakes were completed in this critical incident inspection:

A log was related to an allegation of abuse.

During the course of the inspection, the inspector(s) spoke with various individuals including Registered Practical Nurses (RPN), Personal Support Workers (PSW) and the Director of Care (DOC).

During the course of the inspection, the inspector observed care activities on the units, reviewed relevant policies and procedures and reviewed resident records.

Non-compliance with requirements under the Long-Term Care Homes Act, 2007 (LTCHA) was found. (a requirement under the LTCHA includes the requirements contained in the items listed in the definition of "requirement under this Act" in subsection 2(1) of the LTCHA).

The following constitutes written notification of non-compliance under paragraph 1 of section 152 of the LTCHA.

WN #1: The Licensee has failed to comply with LTCHA, 2007 S.O. 2007, c.8, s. 20. Policy to promote zero tolerance

Specifically failed to comply with the following:

s. 20. (1) Without in any way restricting the generality of the duty provided for in section 19, every licensee shall ensure that there is in place a written policy to promote zero tolerance of abuse and neglect of residents, and shall ensure that the policy is complied with. 2007, c. 8, s. 20 (1).

Findings/Faits saillants :

1. The licensee failed to ensure that two people followed the home's policy related the zero tolerance of abuse of residents.

The home's zero tolerance of abuse policy states that any allegations of resident abuse will be reported immediately.

A review of the home's investigation notes indicated that a person witnessed an allegation of abuse from a PSW to a resident. The person did not immediately report the witnessed abuse. Another person had also witnessed an allegation of abuse from the PSW to the resident and did not report the incident immediately. The DOC confirmed that these two people did not report the allegation of resident abuse immediately, as required within the home's zero tolerance of abuse policy. Failure to immediately report an allegation of resident abuse resulted in the possibility that this resident continued to be abused by this PSW.

WN #2: The Licensee has failed to comply with LTCHA, 2007 S.O. 2007, c.8, s. 3. Residents' Bill of Rights

Specifically failed to comply with the following:

s. 3. (1) Every licensee of a long-term care home shall ensure that the following rights of residents are fully respected and promoted:

1. Every resident has the right to be treated with courtesy and respect and in a way that fully recognizes the resident's individuality and respects the resident's dignity. 2007, c. 8, s. 3 (1).

Findings/Faits saillants :

1. The licensee failed to ensure that two residents were treated with courtesy and respect by a PSW.

Two people stated that they had observed a PSW being inappropriate with their actions to a resident. The home conducted an investigation and the DOC concluded that this PSW did not treat these two residents with courtesy and respect. The failure to treat residents with courtesy and respect in this situation resulted in emotional harm during the care they received by this PSW.

**WN #3: The Licensee has failed to comply with LTCHA, 2007 S.O. 2007, c.8, s. 23.
Licensee must investigate, respond and act**

Specifically failed to comply with the following:

**s. 23. (1) Every licensee of a long-term care home shall ensure that,
(a) every alleged, suspected or witnessed incident of the following that the
licensee knows of, or that is reported to the licensee, is immediately investigated:
(i) abuse of a resident by anyone,
(ii) neglect of a resident by the licensee or staff, or
(iii) anything else provided for in the regulations; 2007, c. 8, s. 23 (1).
(b) appropriate action is taken in response to every such incident; and 2007, c. 8,
s. 23 (1).
(c) any requirements that are provided for in the regulations for investigating and
responding as required under clauses (a) and (b) are complied with. 2007, c. 8, s.
23 (1).**

Findings/Faits saillants :

1. The licensee failed to ensure that an RPN took the appropriate actions after an allegation of abuse was made from a PSW to a resident.

A review of the home's investigation indicated that a person informed the RPN of an allegation of resident abuse from a PSW. The DOC confirmed that the RPN did not take the appropriate actions after hearing about the allegation from the person. Failure to act after an allegation of abuse was made resulted in the possibility that this resident continued to be abused by this PSW.

WN #4: The Licensee has failed to comply with O.Reg 79/10, s. 97. Notification re incidents

Specifically failed to comply with the following:

s. 97. (1) Every licensee of a long-term care home shall ensure that the resident's substitute decision-maker, if any, and any other person specified by the resident,
(a) are notified immediately upon the licensee becoming aware of an alleged, suspected or witnessed incident of abuse or neglect of the resident that has resulted in a physical injury or pain to the resident or that causes distress to the resident that could potentially be detrimental to the resident's health or well-being; and
(b) are notified within 12 hours upon the licensee becoming aware of any other alleged, suspected or witnessed incident of abuse or neglect of the resident. O. Reg. 79/10, s. 97 (1).

Findings/Faits saillants :

1. The licensee failed to ensure that a resident's substitute decision maker (SDM) was informed within 12 hours after the resident made an allegation of abuse from the PSW.

During the home's investigation, a resident had made allegations of abuse from a PSW during their care. The DOC stated they did not notify the resident's SDM after the allegation was made by the resident. Failure to report an allegation of abuse from this resident to their SDM resulted in the SDM not becoming able to participate in this resident's care.

Additional Required Actions:

VPC - pursuant to the Long-Term Care Homes Act, 2007, S.O. 2007, c.8, s.152(2) the licensee is hereby requested to prepare a written plan of correction for achieving compliance ensure that the resident's substitute decision-maker, if any, and any other person specified by the resident, are notified within 12 hours upon the licensee becoming aware of any other alleged, suspected or witnessed incident of abuse or neglect of the resident, to be implemented voluntarily.

WN #5: The Licensee has failed to comply with O.Reg 79/10, s. 98. Every licensee of a long-term care home shall ensure that the appropriate police force is immediately notified of any alleged, suspected or witnessed incident of abuse or neglect of a resident that the licensee suspects may constitute a criminal offence.
O. Reg. 79/10, s. 98.

Findings/Faits saillants :

1. The licensee failed to ensure that the police were notified related to an allegation of abuse from a PSW to the resident.

A review of the home's investigation notes and the CIS report did not indicate that the police were notified about the incident. The DOC stated they did not contact the police related to the allegation of abuse and should have done so.

An order was made by taking the following factors into account:

Severity: There was actual risk of harm to two residents because due to the delay of reporting the witnessed allegations of abuse, the PSW was at risk to continue to abuse these residents.

Scope: The scope of this non-compliance demonstrated a pattern, as there were two out of three residents reviewed and two of those residents were involved in an alleged abuse interaction with this PSW.

Compliance History: Multiple WNs and VPCs were issued to the home related to different sub-sections of the legislation in the past 36 months. (760)
