**The purpose of this inspection was to conduct a Critical Incident System inspection.**

A follow up log to Compliance Order (CO) #001, LTCHA s. 20 (1), related to prevention of abuse and neglect, issued under inspection #2021\_882760\_0024, on July 13, 2021, with a compliance date of August 9, 2021, was inspected;

A follow up log to Compliance Order (CO) #001, , O. Reg 79/10 s. 88 (2), related to housekeeping and pest control, issued under inspection #2021\_598570\_0011, on May 17, 2021, with a compliance date of August 17, 2021, was inspected.
