Inspection Summary/Résumé de l'inspection

The purpose of this inspection was to conduct a Critical Incident System inspection.

This inspection was conducted on the following date(s): August 7, 11, 12, 13, 2020

This inspection was conducted in reference to intake log #003935-20, CIS #2675-000002-20 and #2675-000003-20, related to alleged resident to resident abuse resulting in injury to resident #001.

During the course of the inspection, the inspector(s) spoke with the Chief Executive Officer, the Director of Care, the Nursing Care Coordinator, Registered Nurses and Personal Support Workers.

During the course of the inspection, the Inspector observed video surveillance tapes of resident to resident interactions, reviewed resident health care records and Critical Incident System reports (CIS) and relevant licensee investigation notes, and reviewed policies and procedures related to zero tolerance of abuse and neglect.
