The following constitutes written notification of non-compliance under paragraph 1 of section 152 of the LTCHA.

Non-compliance with requirements under the Long-Term Care Homes Act, 2007 (LTCHA) was found. (A requirement under the LTCHA includes the requirements contained in the Items listed in the definition of "requirement under this Act" in subsection 2(1) of the LTCHA.)

WN #1: The licensee has failed to comply with the LTCHA, 2007, S.O., 2007, c.8, s. 15(2)(a). Every licensee of a long-term care home shall ensure that,

(a) the home, furnishings and equipment are kept clean and sanitary; and

Findings:

- 1. Various identified resident bedroom floors were noted to be dusty or had visible debris behind furniture. Some rooms have paint chips stuck to the floor. Many rooms noted to have dusty overbed light covers.
- 2. Stained privacy curtains noted in nine resident rooms.
- 3. Wall or bathroom door surfaces noted to be visibly dirty or stained in 10 rooms.
- 4. The tub room noted to have dead insects inside of the light covers and accumulated dust on the wall near
- 5. A soiled utility room noted to have stained walls around the hopper and 2 dusty ceiling vents.
- 6. Kitchen build-up noted around fixed table legs and equipment and under stoves.
- 7. Service Corridor floors very dirty, build-up along baseboards, lots of items stored on one side not in use. making floor cleaning difficult.

Additional Required Actions:

VPC – pursuant to the Long-Term Care Homes Act, 2007, S.O. 2007, c.8, s.152(2) the licensee is hereby requested to prepare a written plan of correction for achieving compliance with s. 15(2)(a) in respect to ensuring that the home, furnishings and equipment are kept clean and sanitary, to be implemented voluntarily.

WN #2: The licensee has failed to comply with O. Reg. 79/10, s. 87(2)(d). As part of the organized program of housekeeping under clause 15 (1) (a) of the Act, the licensee shall ensure that procedures are developed and implemented for, addressing incidents of lingering offensive odours.

Findings:

Soiled and/or wet briefs are not disposed of in a manner to contain odours. Personal service workers were noted to be disposing unbagged or uncontained soiled briefs into a soiled linen hamper, whereby the hamper was not designed with an air -tight compartment to contain odour. The odours were detected in the corridor, emanating from the hamper.
