Non-compliance with requirements under the Long-Term Care Homes Act, 2007 (LTCHA) was found. (A requirement under the the definition of "requirement under this Act" in subsection 2(1) of the LTCHA.)

The following constitutes written notification of non-compliance under paragraph 1 of section 152 of the LTCHA.

WN #1: The Licensee has failed to comply with LTCHA, 2007 S.O. 2007, c.8, s. 19. Duty to protect Specifically failed to comply with the following subsections:

s. 19. (1) Every licensee of a long-term care home shall protect residents from abuse by anyone and shall ensure that residents are not neglected by the licensee or staff. 2007, c. 8, s. 19 (1).

Findings/Faits saillants:

An identified resident was not protected from abuse by a staff member in the home. In 2011, a health care aide was witnessed by another worker to have approached a resident who was sitting in their wheelchair. The worker loudly pronounced to the resident that they did not belong in that particular area of the home. The resident was told to put their feet down so they could have their wheelchair repositioned. The resident did not comply and tried to prevent the worker from repositioning them. The worker than tried to force the resident from the area but the resident resisted. The worker then grabbed the resident and spoke to them in a threatening and intimidating manner. A witness told the worker to leave the resident alone, and the worker then left the resident in the corridor. The witness reported the incident immediately to their superiors. The management of the home conducted a follow-up investigation and took appropriate actions.

Additional Required Actions:

VPC - pursuant to the Long-Term Care Homes Act, 2007, S.O. 2007, c.8, s.152(2) the licensee is hereby requested to prepare a written plan of correction for achieving compliance to ensure that residents are protected from abuse by anyone, to be implemented voluntarily.
