The purpose of this inspection was to conduct a Complaint inspection.

During the course of the inspection, the inspector(s) spoke with the Administrator, the Director of Care, the Infection Prevention and Control Program Coordinator and non registered nursing staff.

During the course of the inspection, the inspector(s) conducted a walk-through of the home, viewed the disinfectant used by staff to clean and disinfect resident care equipment, reviewed the home's policy titled "Management of Scabies" (index: LTC-I-520-ON), reviewed documentation provided by the Administrator pertaining to the home's response to a scabies infestation in March/April 2012 and reviewed a Critical Incident report.
