The following constitutes written notification of non-compliance under paragraph 1 of section 152 of the LTCHA.

WN #1: The Licensee has failed to comply with O. Reg. 79/10, s.124

Every licensee of a long-term care home shall ensure that drugs obtained for use in the home, except drugs obtained for any emergency drug supply, are obtained based on resident usage, and that no more than a three-month supply is kept in the home at any time.

Findings:

1. According to the health file, the resident was prescribed pain medication on a regular schedule. The resident did not receive the medication for 2 days in July 2010 due to no supply. The supply of the resident's medication was not obtained based on the resident's usage.
