The purpose of this inspection was to conduct a Follow up inspection.

This inspection was conducted on the following date(s): October 11, 12, and 13, 2017

Two critical incidents, both related to allegations of resident to resident sexual abuse, were inspected concurrently.

During the course of the inspection, the inspector(s) spoke with the Executive Director (ED), the Director of Care (DOC), the Environmental Service Manager (ESM), the Food Service Manager (FSM), a Registered Nurse (RN), Registered Practical Nurses (RPNs), Personal Support Workers (PSWs), a Housekeeping Aide, an Activation Aide, a family member and residents.

A tour of the home was completed and observations were made of resident to resident interactions as well as staff to resident interactions during care provision. A review was also completed of residents' health records, the Licensee's internal investigation records, the Licensee's training records on abuse prevention, and BSO monthly meeting minutes over a three month period. A review was also completed of relevant policies and procedures related to zero tolerance of abuse and neglect as well as responsive behavior management in the home.
