WN #1: The Licensee has failed to comply with O.Reg 79/10, s. 8. Policies, etc., to be followed, and records Specifically failed to comply with the following subsections:

s. 8. (1) Where the Act or this Regulation requires the licensee of a long-term care home to have, institute or otherwise put in place any plan, policy, protocol, procedure, strategy or system, the licensee is required to ensure that the plan, policy, protocol, procedure, strategy or system,
(a) is in compliance with and is implemented in accordance with applicable requirements under the Act; and
(b) is complied with. O. Reg. 79/10, s. 8 (1).

Findings/Faits sayants :

1. The homes policy LTC-N-90 diabetes management policy (Standard 3 hyperglycemia management) states, " Notify the Physician/Nurse Practitioner NP for further investigations, including potential medication adjustment, if the blood glucose is greater the 20 mmol/l: greater 15 mmol/l on two successive testings. This policy was not complied with as evidenced by the following:

A review of a residents health care record indicated that the attending physician had not been notified.
