Inspection Summary/Résumé de l'inspection



The purpose of this inspection was to conduct a Resident Quality Inspection inspection.

This inspection was conducted on the following date(s): September 8, 12, 13, 14, 15, and 16, 2016.

004733-16 - 2624-000005-16 Critical Incident related to alleged staff to resident abuse; and
019709-16 - 2624-000010-16 Critical Incident related to alleged visitor to resident abuse.**

During the course of the inspection, the inspector(s) spoke with the Executive Director, Director of Care, Environmental Services Supervisor, Maintenance/Janitor, Resident Assessment Instrument (RAI)/Staff Educator, Registered Nurse, Housekeeper, Activation Aide, Personal Support Workers, Resident Council Representative and families.

The inspectors also toured the home, observed medication administration, medication storage; reviewed relevant clinical records, policies and procedures, meeting minutes, schedules, investigation reports; posting of required information; observed provision of resident care, resident-staff interactions, and observed the general maintenance, cleanliness, safety and condition of the home.

Plan of care**

Specifically failed to comply with the following:

s. 6. (2) The licensee shall ensure that the care set out in the plan of care is based on an assessment of the resident and the needs and preferences of that resident. 2007, c. 8, s. 6 (2).

Findings/Faits saillants :

1. The licensee has failed to ensure that the plan of care was based on an assessment of the resident and the resident's needs and preferences.

An interview with resident #014 on September 12, 2016, revealed the resident was upset due to the timing of care being provided by the staff.

A record review confirmed the timing of care for this resident.

An interview on September 13, 2016, with PSW #109 confirmed the timing of care for this resident.

Interviews on September 13, 2016, with the Director of Care (DOC) #111 and the Executive Director #100 confirmed the home had been providing care to some residents based on a diagnosis and it was the homes expectation that the plan of care for the resident should have been based on the residents needs and preferences for the bathing schedule.
