Specifically failed to comply with the following:

s. 20. (1) Without in any way restricting the generality of the duty provided for in section 19, every licensee shall ensure that there is in place a written policy to promote zero tolerance of abuse and neglect of residents, and shall ensure that the policy is complied with. 2007, c. 8, s. 20 (1).

1. The Licensee failed to comply with the written policy to promote zero tolerance of abuse and neglect of residents, and shall ensure that the policy is complied with.

The homes policy RCS P-10 for Abuse or Neglect B: When Resident abuse or neglect is suspected:

On becoming aware of abuse or neglect, suspected abuse or neglect, the person first having knowledge of this shall immediately inform the Director at the MOHLTC and the Director of Nursing/or Delegate or if not available, the Administrator.

The Administrator or Director of Nursing must notify Ministry of Health, Long Term Care Branch, and the Vice-President of Operations. Section 24 (1) of the LTCHA, requires that a person who has reasonable grounds to suspect that “abuse of a resident by anyone or neglect of a resident by the licensee or staff that resulted in harm or risk to the resident” shall immediately report the suspicion and information in which is based to the Director.

The Director of Care was aware of a number of incidents involving two residents of alleged abuse and failed to notify the Ministry of Health and Long Term Care per section 24 (1) as per their policy.

Executive Director confirmed that it is the home's expectation to report the incidents of physical abuse resulting in injury per section 24 (1) of the Act immediately to the Director. [s. 20. (1)]

Additional Required Actions:

***VPC - pursuant to the Long-Term Care Homes Act, 2007, S.O. 2007, c.8, s.152(2)
the licensee is hereby requested to prepare a written plan of correction for
achieving compliance that there is a written policy to promote zero tolerance of
abuse and neglect of residents, and shall ensure that the policy is complied with,
to be implemented voluntarily.***
