Specifically failed to comply with the following:

- s. 6. (1) Every licensee of a long-term care home shall ensure that there is a written plan of care for each resident that sets out,**
(a) the planned care for the resident; 2007, c. 8, s. 6 (1).
(b) the goals the care is intended to achieve; and 2007, c. 8, s. 6 (1).
(c) clear directions to staff and others who provide direct care to the resident.
2007, c. 8, s. 6 (1).

Findings/Faits saillants :

1. The licensee did not ensure that there is a written plan of care for each resident that sets out the planned care for the resident, the goals the care is intended to achieve and clear directions to staff and others who provide direct care to the resident.

- a) The resident assessment protocol (RAP) for resident #035 identifies nutritional concerns.
- b) The RAP further includes the resident receives an altered textured diet.
- c) The recent nutritional and hydration risk assessment elaborates on the reason for the resident's nutritional risk.
- d) The written plan of care does not address the planned care for the resident, the goals the care is intended to achieve and clear directions to staff and others who provide direct care to the resident related to the nutritional risk concerns.
- e) One staff confirmed the written plan of care does not include the above required information and advised the written plan of care would be revised on this date. [s. 6. (1)]

Additional Required Actions:

**VPC - pursuant to the Long-Term Care Homes Act, 2007, S.O. 2007, c.8, s.152(2)
the licensee is hereby requested to prepare a written plan of correction for
achieving compliance to ensure that there is a written plan of care for each
resident that sets out the planned care for the resident, the goals the care is
intended to achieve and clear directions to staff and others who provide direct
care to the resident., to be implemented voluntarily.**
