The purpose of this inspection was to conduct a Follow up inspection.

**This inspection was conducted on the following date(s): November 26 - 30, 2018
and December 3 - 7, 2018.**

The following intakes were inspected on during this Follow up inspection:

- One intake related to compliance order (CO) #001 that was issued during inspection #2017_491647_0021 for s. 6 (1) (c) of the Long-Term Care Homes Act (LTCHA), specific to plan of care providing clear direction to staff.**
- One intake related to CO #002 that was issued during inspection #2017_491647_0021 for s. 6 (7) of the LTCHA, specific to care being provided as per the plan of care.**

A Complaint inspection #2018_657681_0027 and a Critical Incident System inspection #2018_657681_0028 were conducted concurrently with this inspection.

During the course of the inspection, the inspector(s) spoke with the Administrator, Co-Director of Care (Co-DOC), Staff Educators, Nutrition Manager, Resident and Family Services Coordinator, Restorative Care Coordinator, Registered Dietitian (RD), Registered Nurses (RNs), Registered Practical Nurses (RPNs), Personal Support Workers (PSWs), Dietary Aides, family members, and residents.

The Inspectors also conducted a tour of the resident care areas, reviewed relevant resident care records, home investigation notes, home policies, personnel files and observed resident rooms, resident common areas, and the delivery of resident care and services, including staff to resident interactions.
