The purpose of this inspection was to conduct a Complaint inspection.

This inspection was conducted on the following date(s): July 5-9, and July 12-13, 2021.

The following intakes were completed in this Complaint inspection:

Log #008817-21 was related to concern with a resident's care.

Log #010292-21 was related to concern with warm home air temperatures.

During the course of the inspection, the inspector(s) spoke with the Administrator, the Co-Directors of Care, Assistant Directors of Care, Registered Nurses (RN), Registered Practical Nurses (RPN), Personal Support Workers (PSWs), and residents.

During the course of the inspection, the inspectors observed resident and staff interactions, and the home's air temperatures. They reviewed clinical health records, relevant home policies and procedures, and other pertinent documents.

This inspection was completed concurrently with inspection 2021\_750539\_0007.

Inspector Robert Spizzirri #705751 was also present during the inspection.

WN #1: The Licensee has failed to comply with O.Reg 79/10, s. 21. Air temperature Specifically failed to comply with the following:

s. 21. (3) The temperature required to be measured under subsection (2) shall be documented at least once every morning, once every afternoon between 12 p.m. and 5 p.m. and once every evening or night. O. Reg. 79/10, s. 21 (3).

Findings/Faits saillants:

1. The licensee has failed to ensure that the temperatures for at least two resident bedrooms in different parts of the home, one resident common area on every floor of the home, and every designated cooling area of the home were measured and documented in writing at least once every morning, once every afternoon between 12 p.m. and 5 p.m. and once every evening or night.

The Administrator stated that temperatures were not being measured or documented in any resident bedrooms, resident common areas, or cooling areas, at three times per day frequency until June 11, 2021. There were several entries in the home's temperature log records that showed that the temperatures of these areas were not being documented once every morning, afternoon, and evening or night from June 11-27, 2021.

A resident shared that there were times when they felt their room was either too warm or too cold, which made them feel uncomfortable.

By not measuring and documenting the temperatures of resident bedrooms, resident common areas, and designated cooling areas, three times per day, the home may be unable to identify when there was a temperature concern. This puts residents at risk for developing a heat related illness.

## Additional Required Actions:

VPC - pursuant to the Long-Term Care Homes Act, 2007, S.O. 2007, c.8, s.152(2) the licensee is hereby requested to prepare a written plan of correction for achieving compliance to ensure that the temperature is measured and documented in writing, at a minimum in the following areas of the home, at least two resident bedrooms in different parts of the home, one resident common area on every floor of the home, and every designated cooling area of the home, at least once every morning, once every afternoon between 12 p.m. and 5 p.m. and once every evening or night, to be implemented voluntarily.
