Inspection Summary/Résumé de l'inspection

The purpose of this inspection was to conduct a Complaint inspection.

During the course of the inspection, the inspector(s) spoke with the Director of Care, registered staff and personal support worker staff on the unit, the Kinesiologist and identified residents related to complaint Log # H-000570-12.

During the course of the inspection, the inspector(s) conducted a review of the health file for the residents identified in this complaint, reviewed the home's policies and procedures related to continence care and observed care on the identified unit.

PLEASE NOTE: Four areas of non compliance were found related to the licensee's failure to review and revise the plan of care to reflect changes in a resident's health status, care not being provided as per the resident's plan of care, medication not administered in accordance with the directions for use by the prescriber and goals and objectives not identified for the home's policy and procedure related to Continence Care and Bowel Management.
