WN #1: The Licensee has failed to comply with LTCHA, 2007 S.O. 2007, c.8, s. 6. Plan of care

Specifically failed to comply with the following subsections:

s. 6. (10) The licensee shall ensure that the resident is reassessed and the plan of care reviewed and revised at least every six months and at any other time when,

(a) a goal in the plan is met;

(b) the resident's care needs change or care set out in the plan is no longer necessary; or

(c) care set out in the plan has not been effective. 2007, c. 8, s. 6 (10).

## Findings/Faits saillants :

[LTCHA 2007, S.O. 2007, c.8, s. 6(10)(b)] The licensee did not ensure that the resident is reassessed and the plan of care reviewed and revised at least every six months and at any other time when,

(b) the resident's care needs change or care set out in the plan is no longer necessary.

In 2011, the resident's physician wrote a letter requesting that the home provide specific environmental conditions for the resident. In response, the home nursing staff instituted a plan to monitor the environment and the resident's plan of care was updated with clear directions. According to registered staff, the plan was followed in 2011. Due to satisfactory conditions and, with the support of the resident's family, the monitoring was discontinued in February 2012.

Several months later in 2012, the environmental conditions were re-identified by family. The resident's most recent plan of care gives clear direction for staff that the environment be continuously monitored. Staff confirmed that monitoring had not been completed since February 2012. No monitoring records could be produced when requested for 2011 or 2012.

## Additional Required Actions:

VPC - pursuant to the Long-Term Care Homes Act, 2007, S.O. 2007, c.8, s.152(2) the licensee is hereby requested to prepare a written plan of correction for achieving compliance to ensure that the resident's plan of care is reviewed and revised when the care set out in the plan is no longer necessary, to be implemented voluntarily.
