**PLEASE NOTE:** Three non-compliance were found related to Licensee's failure to comply with home's policy and procedure related to Nutrition and Hydration flow sheets , Licensee's failure to ensure that the resident is reassessed and the plan of care reviewed and revised at least every six months and at any other time when, the resident's care needs change or care set out in the plan is not longer necessary and the Licensee's failure to ensure that the drugs are administered to resident in accordance with the direction for use specified by the prescriber under the Long Term-Care Homes Act.

These non-compliances [O.Reg 79/10, s. 8(1)b], [LTCHA S. 6(10)b] and [O.Reg 79/10, s. 131(2)] were issued in RQI inspection #2012\_026147\_0013, commenced on April 13, 2012 and is contained in the Report of that inspection.
