WN #1: The Licensee has failed to comply with O.Reg 79/10, s. 71. Menu planning

Specifically failed to comply with the following:

s. 71. (5) The licensee shall ensure that an individualized menu is developed for each resident whose needs cannot be met through the home's menu cycle. O. Reg. 79/10, s. 71 (5).

Findings/Faits saillants :

1. The licensee did not ensure that an individualized menu was developed for resident #0001 and #0003 as their needs could not met through the home's menu cycle.

The planned menu served for lunch on May 21, 2014 consisted of macaroni and cheese, baked parmesan tomato, chilled peaches. Resident #0001 and #0003 were served the main course macaroni and cheese with no vegetable. The dietary aide confirmed that the identified residents were not served tomatoes due to diet restrictions and the menu choices for therapeutic diet food variation were not prepared and available.

The individualize menu for resident #0001 and resident #0003 were not planned to meet their dietary needs through the home's menu cycle.

Food Service Manager interviewed reported that that the new Spring/Summer menus were implemented on May 19, 2014. However, an individualized menu for the resident was not planned by the Registered Dietitian in consultation with the resident based on individual needs and personal preferences. [s. 71. (5)]

Additional Required Actions:

VPC - pursuant to the Long-Term Care Homes Act, 2007, S.O. 2007, c.8, s.152(2) the licensee is hereby requested to prepare a written plan of correction for achieving compliance ensuring that an individualized menu is developed for each resident whose needs cannot be met through the home's menu cycle, to be implemented voluntarily.
