The purpose of this inspection was to conduct a Follow up inspection.

An inspection (2017-561583-0002) was previously conducted January 5 to 27, 2017, at which time an order (#001) was issued related to bed safety. For this follow up inspection, the conditions laid out in the order were determined to have been met.

During the course of the inspection, the inspector(s) spoke with the Executive Director, Director of Care, registered staff, and personal support workers.

During the course of the inspection, the inspector toured four home areas, observed residents and resident bed systems, reviewed bed audit records, resident clinical bed safety assessments, bed safety policies, procedures and clinical forms.
