The following constitutes written notification of non-compliance under paragraph 1 of section 152 of the LTCHA.

**Specifically failed to comply with the following subsections:**

**s. 6. (7) The licensee shall ensure that the care set out in the plan of care is provided to the resident as specified in the plan. 2007, c. 8, s. 6 (7).**

**Findings/Faits sayants :**

An identified resident's care was not provided in accordance to the plan of care as set in relation to lab results.

**Additional Required Actions:**

**VPC - pursuant to the Long-Term Care Homes Act, 2007, S.O. 2007, c.8, s.152(2) the licensee is hereby requested to prepare a written plan of correction for achieving compliance by ensuring that all INR results received at the home will be addressed in accordance to the residents plan of care., to be implemented voluntarily.**
