Non-compliance with requirements under the Long-Term Care Homes Act, 2007 (LTCHA) was found. (A requirement under the LTCHA includes the requirements contained in the items listed in the definition of "requirement under this Act" in subsection 2(1) of the LTCHA.)

The following constitutes written notification of non-compliance under paragraph 1 of section 152 of the LTCHA.

Le non-respect des exigences de la Loi de 2007 sur les foyers de soins de longue durée (LFSLD) a été constaté. (Une exigence de la loi comprend les exigences qui font partie des éléments énumérés dans la définition de « exigence prévue par la présente loi », au paragraphe 2(1) de la LFSLD.

Ce qui suit constitue un avis écrit de non-respect aux termes du paragraphe 1 de l'article 152 de la LFSLD.

WN #1: The Licensee has failed to comply with LTCHA, 2007 S.O. 2007, c.8, s. 6. Plan of care Specifically failed to comply with the following subsections:

- s. 6. (1) Every licensee of a long-term care home shall ensure that there is a written plan of care for each resident that sets out,**
- (a) the planned care for the resident;**
 - (b) the goals the care is intended to achieve; and**
 - (c) clear directions to staff and others who provide direct care to the resident. 2007, c. 8, s. 6 (1).**

Findings/Faits saillants :

1. The licensee has failed to comply with LTCHA, S.O. 2007 s.6.(1)(c) when the written plan of care did not set out clear direction to staff and others who provide direct care to the resident in regards to personal care in the evenings.

Family met with DOC to voice concerns related to the provision of personal care for resident #001. It was discussed and agreed that personal care would be provided routinely for resident #001 prior to the resident going to bed.

RPN and PCA verified that personal care was completed nightly for resident #001 prior to the resident going to bed. RPN and PCA have noted that the resident will occasionally refuse personal care when offered.

The written plan of care reviewed directs staff to provide "personal care as required". The written plan of care does not give clear direction to staff and others who provide direct care to resident #001 related to the provision personal care in the evening as discussed.
