The purpose of this inspection was to conduct a Critical Incident System inspection.

This inspection was conducted on the following date(s): December 11, 12, 2013

Two critical incidents, logs O-000132-13 and O-000444-13 were inspected concurrently.

During the course of the inspection, the inspector(s) spoke with Residents, the General Manager, the Assistant General Manager, the RAI MDS Coordinator, Registered staff and Personal Care Aides.

During the course of the inspection, the inspector(s) reviewed clinical health records, the licensee's internal investigation records, the licensee's policy related to the prevention of abuse and neglect and the record of staff education related to abuse, residents' rights and mandatory reporting.

The following Inspection Protocols were used during this inspection: Prevention of Abuse, Neglect and Retaliation

Findings of Non-Compliance were found during this inspection.

WN #1: The Licensee has failed to comply with O.Reg 79/10, s. 98. Every licensee of a long-term care home shall ensure that the appropriate police force is immediately notified of any alleged, suspected or witnessed incident of abuse or neglect of a resident that the licensee suspects may constitute a criminal offence. O. Reg. 79/10, s. 98.

Findings/Faits saillants:

1. Log O-000132-13, Log O-000444-13

There is no evidence in Resident#1 and Resident#2's clinical records or in the individual critical incident reports that the police were notified immediately of two separate incidents of staff to resident abuse.

Interview with the Assistant General Manager indicated that the licensee did not notify the police until after the internal investigations were completed. [s. 98.]

Additional Required Actions:

VPC - pursuant to the Long-Term Care Homes Act, 2007, S.O. 2007, c.8, s.152(2) the licensee is hereby requested to prepare a written plan of correction for achieving compliance to ensure that the appropriate police force is immediately notified of any alleged, suspected or witnessed incident of abuse or neglect of a resident. to be implemented voluntarily.

WN #2: The Licensee has failed to comply with LTCHA, 2007 S.O. 2007, c.8, s. 24. Reporting certain matters to Director Specifically failed to comply with the following:

- s. 24. (1) A person who has reasonable grounds to suspect that any of the following has occurred or may occur shall immediately report the suspicion and the information upon which it is based to the Director:
- 1. Improper or incompetent treatment or care of a resident that resulted in harm or a risk of harm to the resident. 2007, c. 8, s. 24 (1), 195 (2).
- 2. Abuse of a resident by anyone or neglect of a resident by the licensee or staff that resulted in harm or a risk of harm to the resident. 2007, c. 8, s. 24 (1), 195 (2).
- 3. Unlawful conduct that resulted in harm or a risk of harm to a resident. 2007, c. 8, s. 24 (1), 195 (2).
- 4. Misuse or misappropriation of a resident's money. 2007, c. 8, s. 24 (1), 195 (2).
- 5. Misuse or misappropriation of funding provided to a licensee under this Act or the Local Health System Integration Act, 2006. 2007, c. 8, s. 24 (1), 195 (2).

Review of Resident #1 and #2's clinical documentation, the critical incident reports and the licensee's investigations into the separate incidents indicate the MOHLTC was not immediately notified the alleged incidents of staff to resident abuse. [s. 24. (1)]

WN #3: The Licensee has failed to comply with O.Reg 79/10, s. 104. Licensees who report investigations under s. 23 (2) of Act Specifically failed to comply with the following:

s. 104. (2) Subject to subsection (3), the licensee shall make the report within 10 days of becoming aware of the alleged, suspected or witnessed incident, or at an earlier date if required by the Director. O. Reg. 79/10, s. 104 (2).

Findings/Faits saillants:

1. Log O-000132-13

Review of Resident #2's clinical documentation and the licensee's investigation into the incident indicated the alleged staff to resident abuse occurred on an identified date.

The MOHLTC was not notified of the incident until the critical incident report was submitted 46 days post incident. [s. 104.(2)]
