An inspection (2013-189120-0050) was previously conducted on August 13, 2013 at which time two Orders were issued for non compliance related to resident assessments and bed safety. For this inspection, all conditions required under the two Orders have been met.

During the course of the inspection, the inspector(s) spoke with the Administrator and Assistant Director of Care.

During the course of the inspection, the inspector(s) toured three resident rooms and observed the bed systems, verified that the home has a continuous rail use assessment program, reviewed the home's bed safety procedures and associated forms and reviewed three resident care plans.
