The purpose of this inspection was to conduct a Critical Incident System inspection.

This inspection was conducted on the following date(s): July 3, 5 & 6, 2018

The following logs #002799-18 and #002893-18 concerning resident to resident abuse were inspected.

During the course of the inspection, the inspector(s) spoke with Residents, Personal Support Workers (PSW), Registered Practical Nurses (RPN), Registered Nurses (RN), the Director of Care (DOC), the Unit Clerk, Activity Staff and the Administrator. As part of the inspection electronic health care records were reviewed, observations of care and services and multiple staff interviews were completed. Additionally, the critical incidents submitted by the home in response to the above noted incidents, and related policy and procedures were considered.
