The purpose of this inspection was to conduct a Follow up inspection.

This inspection was conducted on the following date(s): April 19 - 21, 2021.

The following intakes were inspected during this Follow-up inspection:

One intake, related to compliance order (CO) #001 that was issued during inspection #2020_669642_0022, regarding s. 23 (1) of O. Reg 79/10 , specific to ensuring every alleged, suspected or witnessed incident of abuse that the licensee knew of, or that was reported to the licensee, was immediately investigated;

One intake, related to CO #001 that was issued from Inspection #2020_669642_0021, regarding r. 9 (1) of O. Reg 79/10 specific to ensuring all doors leading to stairways and the outside of the home other than doors leading to secure outside areas that preclude exit by a resident were kept closed and locked;

One intake, related to CO #003 issued during inspection #2020_669642_0021, regarding s. 230 (6) of O. Reg. 79/10, specific to ensuring emergency fire plans for the home were evaluated and updated at least annually and that the documentation was kept in the home and,

One intake, related to CO# 002 issued during Inspection #2020_669642_0021 regarding s.230 (7) of O. Reg. 79/10, specific to ensuring the home followed their Fire Safety Plan and documentation of all staff that attend fire drills and any changes made to improve the plan.

A Critical Incident Inspection #2021_638542_0008 was conducted concurrently with this Inspection.
