This inspection was conducted on the following date(s): March 29-30, 2022, as an off-site inspection.

-One intake, which was follow up to a Director Order (DR) #400 issued by The Director as part of a Director Review, and the current compliance status, related to s. 145 (1) of the Ontario Regulations (O. Reg.) 79/10, related to the discharge of a resident, with a compliance due date of September 14, 2021.

Follow Up inspection #2022_907692_0010 was conducted concurrently with this inspection.

During the course of the inspection, the inspector(s) spoke with the Administrator, Director of Care (DOC) of another Long-Term Care Home, and Care Coordinator with the Home and Community Care Support Services (HCCSS) North East.
