INSPECTION RESULTS

Non-Compliance Remedied

Non-compliance was found during this inspection and was **remedied** by the licensee prior to the conclusion of the inspection. The inspector was satisfied that the non-compliance met the intent of section 154 (2) and requires no further action.

The licensee has failed to ensure that food service workers successfully completed or were enrolled in a Food Service Worker program; successfully completed an apprenticeship program in the trade of Cook, Institution Cook or Assistant Cook; or entered into a registered training agreement in the trade of Cook, Institutional Cook or Assistant Cook.

Rationale and Summary

A complaint was submitted to the home concerning the qualifications of food service workers at the home.

The Administrator acknowledged that certain food service workers were currently employed at the home; however, they did not have the required qualifications to perform their duties.

Prior to the conclusion of the inspection, proof of enrollment in a Food Service Worker program for the appropriate food service workers and enrollment in a Food Handler Training program for the appropriate food service worker were provided to the Inspector.
