The purpose of this inspection was to conduct a Critical Incident System inspection.

This inspection was conducted on the following date(s): March 13, 14, and 18, 2019.

The following critical incidents were completed during this inspection:

CIS 2802-000020-18 / Intake log #031316-18 related to a fall

CIS 2802-000004-19 / Intake log #004717-19 related to a fall

CIS 2802-000005-19 / Intake log #005231-19 related to allegations of abuse.

During the course of the inspection, the inspector(s) spoke with the Administrator, the Director of Care, the Administrative Assistant, the Physiotherapy Assistant, the Life Enrichment Assistant, Personal Support Workers, a Dietary worker, TNT Security Inc. agency owner, and TNT Security Inc. agency staff.

The inspector also made observations of resident home areas and resident care, as well as staff to resident and resident to resident interactions. Relevant clinical records and reports for identified residents were reviewed, as well as education records for TNT agency staff.
