The purpose of this inspection was to conduct a Critical Incident System inspection.

This inspection was conducted on the following date(s): May 10-14 & 17, 2021.

The following intake was inspected during this Critical Incident System (CIS) inspection:

-an intake related to a medication administration error which resulted in an adverse effect to a resident.

This CIS inspection was conducted concurrently with complaint inspection #2021 829757 0012.

During the course of the inspection, the inspector(s) spoke with the Administrator, Director of Care (DOC), Resident Assessment Instrument (RAI) Coordinator/Team Lead, and a Registered Practical Nurse (RPN).

The Inspector also conducted a daily tour or resident care areas, observed the provision of care and services to residents, staff-to-resident interactions, and reviewed relevant resident health care records, the home's investigation records, as well as specific licensee policies, procedures, and programs.

WN #1: The Licensee has failed to comply with O.Reg 79/10, s. 131. Administration of drugs

Specifically failed to comply with the following:

s. 131. (1) Every licensee of a long-term care home shall ensure that no drug is used by or administered to a resident in the home unless the drug has been prescribed for the resident. O. Reg. 79/10, s. 131 (1).

Findings/Faits saillants:

1. The licensee has failed to ensure that no drug was administered to a resident unless the drug had been prescribed for the resident.

A Registered Practical Nurse (RPN) administered a medication to a resident, which was intended for another resident, and which had not been prescribed for the resident who received it. The RPN admitted that on that day, they had pre-poured medications for two residents, including the resident who received the medication, despite this practice not being permitted in the home. The RPN indicated that they then inadvertently handed the incorrect medication cup to the resident, who then took the medication. As a result of the incident, the resident experienced an adverse effect.

Additional Required Actions:

VPC - pursuant to the Long-Term Care Homes Act, 2007, S.O. 2007, c.8, s.152(2) the licensee is hereby requested to prepare a written plan of correction for achieving compliance to ensure that no drug is used by or administered to a resident in the home unless the drug has been prescribed for the resident, to be implemented voluntarily.
