1. On September 24, 2013, the DOC provided the inspector with the following documents:

- "Sioux Lookout Meno-Ya-Win Health Centre Minutes of LTC Accreditation / Program Committee Meeting" dated May 14, 2007,
- "Long Term Care Committee List",
- the agenda for the "Sioux Lookout Meno-Ya-Win Health Centre Chronic/LTC Meeting" dated May 14, 2007.

The minutes indicate that the satisfaction survey was approved by the LTC Committee and the "Long Term Care Committee List" indicates that, no residents were members of this committee. On Sept 11, 2013 the Director of Care was unable to confirm that management sought the advice of the Residents' Council in developing and carrying out the satisfaction survey and in acting on its results.

On September 11, 2013, staff member # S-100, who is one of the Residents' Council's assistants reported that they were unaware if licensee ever sought the advice of the Residents' Council in developing and carrying out the satisfaction survey and in acting on its results. The licensee failed to seek the advice of the Residents' Council in developing and carrying out the satisfaction survey, and in acting on its results. [s. 85. (3)]
