WN #1: The Licensee has failed to comply with LTCHA, 2007 S.O. 2007, c.8, s. 6. Plan of care

Specifically failed to comply with the following subsections:

s. 6. (7) The licensee shall ensure that the care set out in the plan of care is provided to the resident as specified in the plan. 2007, c. 8, s. 6 (7).

Findings/Faits saillants :

1. The following findings are in relation to inspection log # 0-001464-11

A resident received a bath from one Personal Support Worker (PSW). The PSW did not follow the plan of care which identified that the resident requires two staff provide support for bathing.

WN #2: The Licensee has failed to comply with LTCHA, 2007 S.O. 2007, c.8, s. 15. Accommodation services

Specifically failed to comply with the following subsections:

**s. 15. (2) Every licensee of a long-term care home shall ensure that,
(a) the home, furnishings and equipment are kept clean and sanitary;
(b) each resident's linen and personal clothing is collected, sorted, cleaned and delivered; and
(c) the home, furnishings and equipment are maintained in a safe condition and in a good state of repair. 2007, c. 8, s. 15 (2).**

Findings/Faits saillants :

1. This finding is in relation to log # 0-002985-10.

A resident was being transferred by two staff from bed to wheelchair. The resident was transferred with the assistance of a sit to stand Sara mechanical lift. Once seated in the wheelchair staff observed that the resident had sustained a leg laceration. The resident was transferred to hospital and required 29 sutures to close the wound. The homes internal investigation of the incident indicated that a sharp edge on the residents wheelchair at the location where the foot rest connected to the lower supporting frame of the wheelchair caused the injury.
