The order was originally issued as a result of Resident Quality Inspection #2017_625133_0017 and then subsequently reissued as a result of Follow Up inspection #2017_548592_0006.

During the course of the inspection, the inspector(s) spoke with the Administrator, the Director of Care, registered and non registered nursing staff, residents and a resident's visiting family member.

During the course of the inspection, the Inspector observed identified residents in their bed systems, reviewed identified residents' health care records in relation to bed rail use, and reviewed policies and associated supporting documents related to bed rail use in the home.
